- Social & Recreational Committee
  - o The CAP Christmas party was a major success, with perhaps the largest attendance ever. Kudos to Rina Hicks for an amazing effort.
- By-Laws Committee
  - The Board completed its By-Laws tasks for 2019 and successfully obtained approval for changes from the General Membership
    - ACTION: The Board asked Tim Palombo to confirm that the new Bylaws replaced the old one on the web site (and also the Google Drive).

- Pavilion Rental Agreement
